Introduction

This Statement is intended to supplement the current Product Disclosure Statement ("PDS") prepared by IG Markets Limited ("IG Markets") relating to contracts for differences and other margin trading products, together with any updated or replacement version thereof and any supplementary PDS (if applicable) that may be issued by IG Markets.

Authorisation by Securities Commission

IG Markets has been authorised by the New Zealand Securities Commission (the "Commission") to carry on the business of dealing in specified futures contracts issued by IG Markets and to which IG Markets is a party ("CFDs") pursuant to the Authorised Futures Dealers (IG Markets Limited) Notice 2009. However:

- the Commission's role in authorising futures dealers is limited and does not imply approval or endorsement of the business, trading or solvency of IG Markets; and
- the Commission has not approved any agreements or any disclosure documents of IG Markets.

The following information is included in accordance with the conditions of the Authorisation Notice:

- a) IG Markets may not be subject in all respects to New Zealand law
- b) **Section 7 of the PDS sets out the taxation and GST considerations that may apply to Australian resident customers. This information may not be relevant to you. Returns to New Zealand investors are likely to be affected by New Zealand taxation rules. As a result, any returns to New Zealand investors may differ from the returns to Australian investors described in the PDS.**
- c) **Investors should satisfy themselves as to the tax and GST implications of entering into CFDs;**
- d) entering into CFDs may carry with it a currency exchange risk;
- e) the financial reporting requirements applying in New Zealand and those applying to IG Markets (an English company also registered as a foreign company in Australia) may be different and the financial statements of IG Markets may not be compatible in all respects with financial statements prepared in accordance with New Zealand law.

Agreement as to jurisdiction

- a) In respect of a dispute concerning any CFD, IG Markets:
 - agrees to submit to the non-exclusive jurisdiction of the New Zealand courts;
 - has instructed the New Zealand agent for service referred to in paragraph c) below to accept service on IG Markets' behalf; and
 - agrees that this statement is an agreement with each investor for the purposes of section 389(1)(e) of the Companies Act 1993.
- b) Despite the statements referred to in the preceding paragraph a), the contract in respect of a CFD may not always be enforceable in New Zealand courts.
- c) The Chairman, Bell Gully Solicitors, whose address is HP Tower, 171 Featherston Street, Wellington, has been appointed by the Company to accept service in New Zealand of any documents on its behalf.

Dispute Resolution

IG Markets has clearly laid down internal and external complaint resolution procedures. IG Markets belongs to an independent external resolution scheme operated by Financial Services Complaints Limited (FSCL).

Further details of IG Markets' dispute resolution procedure and the FSCL are set out in section 6.1 of the PDS.

Credit Information and Privacy

IG Markets may use information provided by you to check your identity and /or your credit worthiness. We may use this information in order to assess whether you can open an account with us or at any time during which you have an account with us.

The process of credit checking requires IG Markets to provide your information to a credit reporting agency for that purpose. The agency will in turn hold that information on their systems and use it to provide their credit reporting service to us, including the provision of information about you to us. This updated information held by the agency may also be disclosed to other customers of that credit reporting agency, including, if applicable, any default by you in any payment due to us.
